Shareholder Opportunities

All members of Belvedere Golf & Country Club must either be the primary shareholder or be a spouse/partner/dependent of a shareholder.

New members purchasing an equity share are required to pay a one time entrance fee, our current entrance fee is \$2,500. Members must pay this fee before they become an active member or before they are placed on the waiting list. Once active, members are responsible for yearly membership fees consisting of the annual green fee, capital fee (\$1200/year) and a minimum food & beverage spend (\$600/year).

Belvedere Equity shares are currently priced at \$12,500.

An example of a new members cost to join (for one playing shareholder) is:

\$12,500 - equity share

\$2,500 - entrance fee

\$5,000 + gst - annual prime green fee

\$1,200 + gst - annual capital fee

\$21,510 total for year 1

Membership Categories

Prime Shareholder

Prime Shareholders have unrestricted access to the tee sheet, 7 day advance booking and may book with 3 guests per day (guest rate applies).

Spouse - *Prime, Restricted or Evening*

A Shareholder may sign up their spouse or partner on their membership. Fees vary based on the category selected.

Dependents - *Junior or Intermediate*

A Shareholder may sign up their dependents aged 7-30 on their membership. Annual fees vary based on the age of the dependent. Dependents are allocated to an age bracket based on their age as of April 1st of the current year.
